CURRENT POSITION

Bedford

- The Core Strategy and Rural Issues Development Plan Document was adopted in 2008 covering the period up to 2021.
- A replacement new Local Plan has been prepared, which will extend the plan period up to 2030.
- The Council consulted on a series of proposed main modifications to the Local Plan 2030 between 19 August and 1 October 2019.
- The Inspector has advised that an immediate early review of the Local Plan should occur once it is adopted.
- Adoption of the Local Plan is now scheduled for the week commencing 13th January 2020. The original adoption date was scheduled for December 2019, however the delay occurred as a result of the general election.

Central Bedfordshire

- The Local Plan was submitted to government on the 30 April 2018.
- The Council has now received further correspondence from the Inspectors. This letter, dated 28 October 2019, has been made available as an Examination Document, along with the council's formal response.
- The timescale for adoption of the Local Plan will be dependent upon the timing and outcome of additional examination hearing sessions but is not now anticipated until Winter 2020 at the earliest.

Luton

The Luton Local Plan was adopted in November 2017.
