LOCAL AUTHORITY	CURRENT POSITION
Cambridge	<ul style="list-style-type: none">- The Cambridge City Local Plan was adopted in October 2018.- The Greater Cambridge Shared Planning Service has undertaken the 'Greater Cambridge Local Plan – The First Conversation' consultation, which concluded on 24 February 2020.- The next stage is the Preferred Options (Reg. 18), which is currently scheduled for Autumn 2020 but given the impacts of COVID-19 may be delayed until later in 2020 or early 2021.- Adoption of The Greater Cambridge Local Plan is currently timetabled for Summer 2023.-
East Cambridgeshire	<ul style="list-style-type: none">- The East Cambridgeshire Local Plan was adopted in 2015.- In February 2019, the Council withdrew its emerging Local Plan. The East Cambridgeshire Local Plan 2015 remains in place as the adopted Local Plan for the district.- In October 2019, East Cambridgeshire District Council undertook its first review of its Local Plan 2015, and determined that at that stage, following review, no new Local Plan would be commenced.- In April 2020, a further review of the Local Plan was undertaken, and concluded that its Local Plan 2015 does need to be revised, but only in respect of its strategic housing policies, and because it has an out-of-date housing requirement.- This Local Plan Review (April 2020) confirmed that a future meeting of Full Council will be held where members will be asked to determine whether to commence a Local Plan review in whole or just the part identified in need of revising, and to what timetable (in an updated Local Development Scheme).
Fenland	<ul style="list-style-type: none">- The Fenland Local Plan was adopted in 2014.- The Council is at the first stage in the process of preparing a new Local Plan. Fenland District Council consulted on its Issues & Options document from 11 October and 21 November 2019. The next stage is the Preferred Options consultation (Reg. 18).- All comments received have been taken into consideration during preparation of the Local Plan & CIL Viability Report, which was published by the Council in March 2020, and the consultation on which concluded on 4th May 2020.- The adoption date for the emerging Local Plan is currently timetabled for February 2022.
Huntingdonshire	<ul style="list-style-type: none">- The Huntingdonshire Local Plan was adopted in May 2019.- There is currently no commencement date scheduled for preparation of a new Local Plan.
Peterborough	<ul style="list-style-type: none">- The Peterborough Local Plan was adopted 24 July 2019.- There is currently no commencement date scheduled for preparation of a new Local Plan.
