A four bedroom family home, in the desirable Munster Village, near to several green spaces.

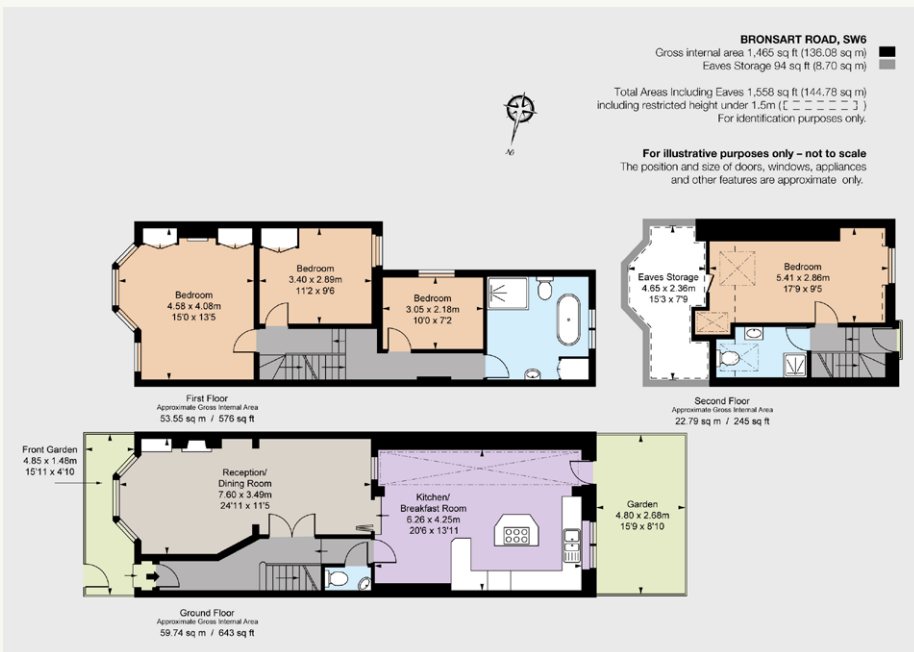
