The relevant planning for Home Farm is under Wealden District Council WD/2019/0883/F. Planning was granted on appeal on 27/04/23 under the following proposal:- Demolition of exisiting buildings as identified on submitted plans. Conversion of the remaining buildings, including three curtilage listed buildings, to create four new dwelling and the erection of one new dwelling to include associated new vehicle parking and turning areas and driveways.

- 4 bed 3 bath single storey detached residence.
 Semi-detached 4 bed with balcony and parking.
- 3. Semi-detached 4 bed with balcony and parking.
- 4. Barn-style centre around a courtyard, 4 bed, 3 bath.
- 5. Luxury detached family home.
