The property

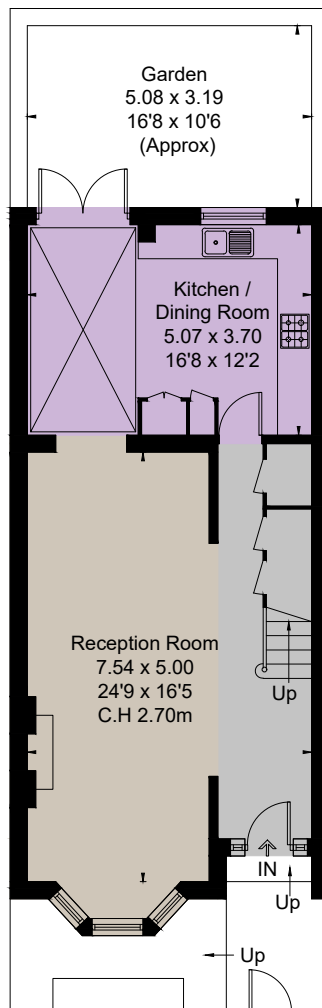

Location

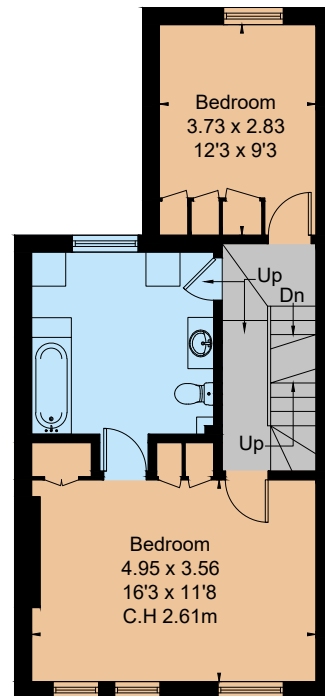

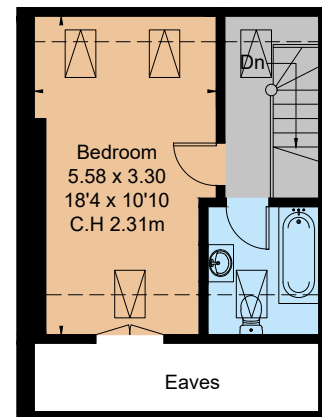




Ground Floor
