Location

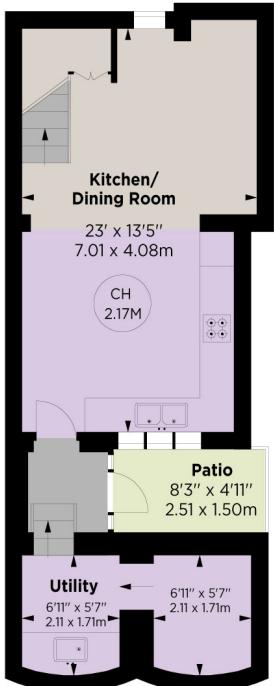

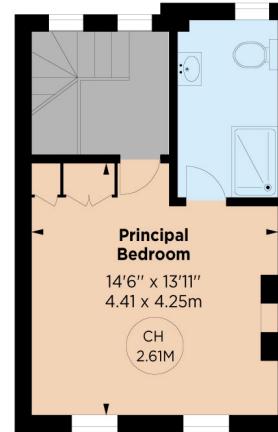
LOWER GROUND FLOOR
