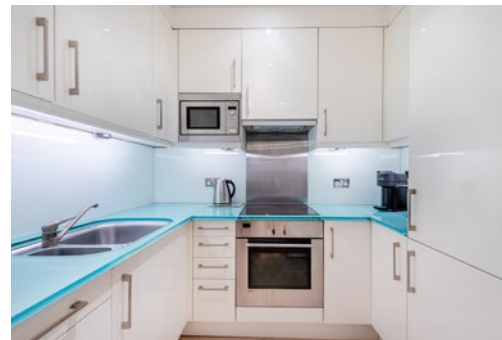

Knightsbridge Station (Piccadilly line) is 0.3 miles away



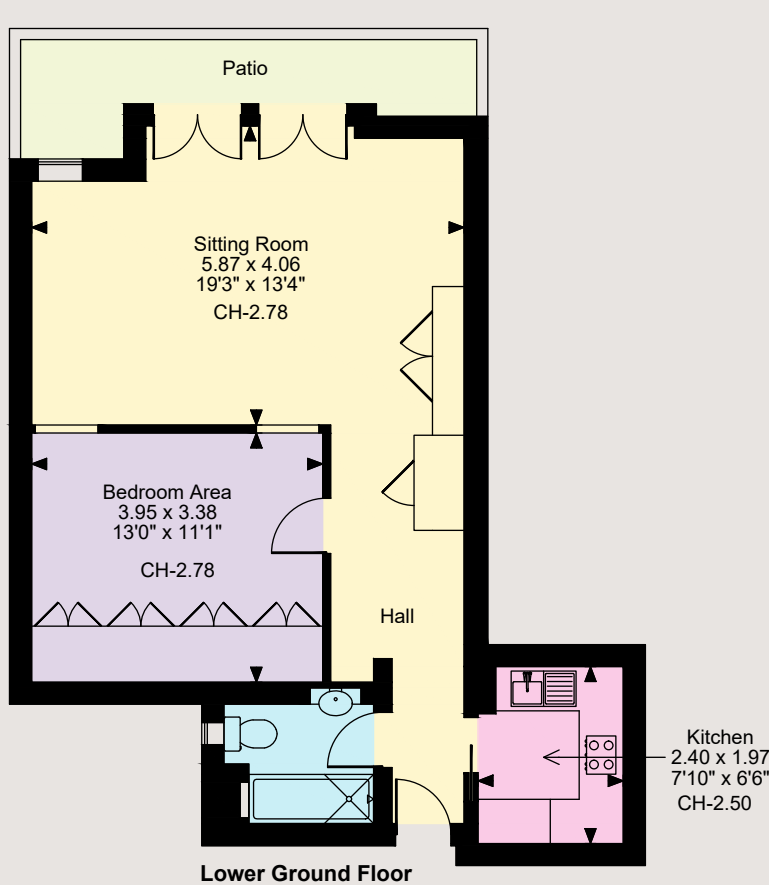
