Additional features include bespoke wardrobes and solid white oak herringbone flooring through

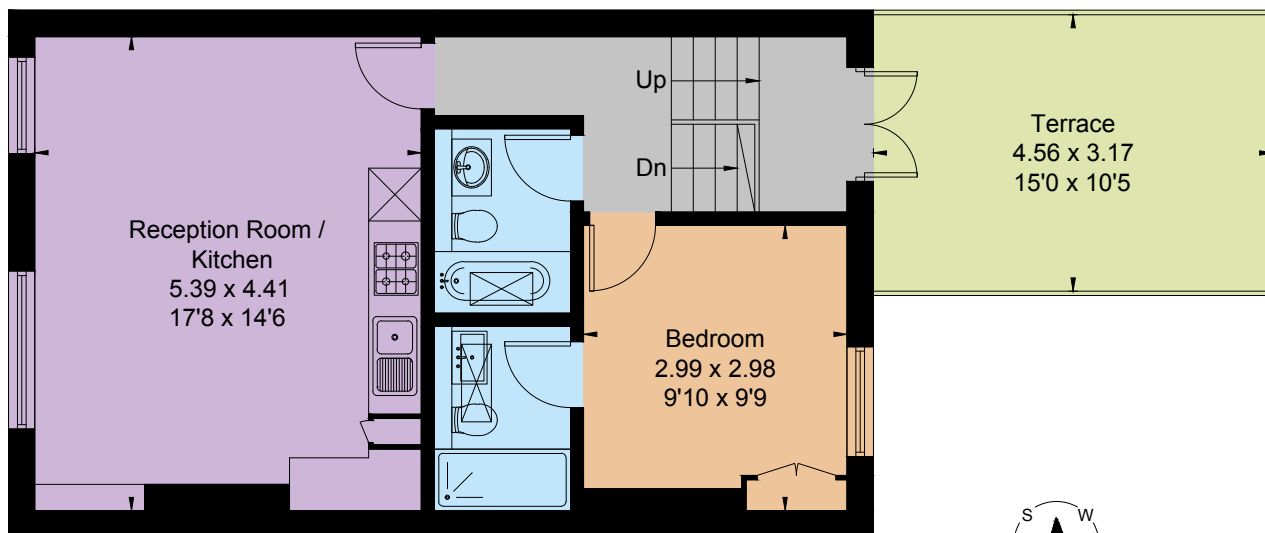

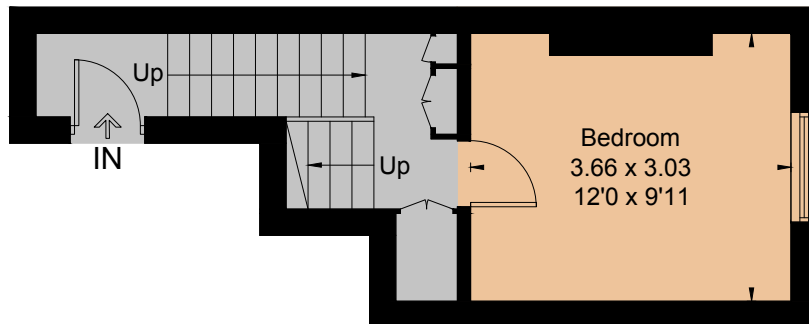








Third Floor
