The property

Stone Walls, which was converted in 2007, is a beautifully presented barn conversion. In 2020 an annexe was built beside and above the garage with its own entrance on Tilton Lane and a dedicated off-street parking place. The remainder of the house has huge flexibility of accommodation and real character with exposed ceiling trusses, stone and brickwork walls, stone window sills and Inglenooks. The house is light and airy throughout and offers a real versatility in terms of room usage.

Emanating from the entrance hall are the annexe internal entrance, a utility room with WC and a staircase leading to bedroom 4/ Study. To the left is the kitchen which forms the centrepiece and hub of the house. This has a range of farmhouse style units with wooden work surfaces and a range cooker. French doors open onto the central courtyard. Beyond, is the drawing room which has a log burning stove and French doors opening onto the garden. A glazed passage leads to the remainder of the accommodation which includes a ground floor bedroom (3) and a family bathroom as well as the sitting room which has French doors opening onto the garden. Upstairs, the principal bedroom has an en suite shower room, dressing room and study. There is a further bedroom with an en suite shower room off the main stairs.

Outside

A five bar gate between high brick gate pillars opens onto a generous parking area with room for multiple vehicles. Ahead is a terrace positioned to get the morning and midday sun. The main garden is located to the west of the house and has a street access from the Tilton Lane. Well planted with mature trees and shrubs, it has a terrace to its southern end with a pergola providing opportunity for sun well into the evening and far reaching countryside views to the south and west.

Location

Stone Walls is situated in beautiful Leicestershire countryside just 500m from Tilton on the Hill, which has a village store and The Rose and Crown pub. The location places Stone Walls in a unique geographical position being almost equidistant from Leicester, Oakham, Uppingham, Melton Mowbray and Market Harborough with junction 21 of the M1 just 14.5 miles away. Trains to London St Pancras International are available from both Leicester and Market Harborough. Schooling is available in both the state and public sector including Stoneygate, Leicester Grammar, Uppingham and Oakham.





Directions

From Market Harborough travel north along the B6047 crossing over the A47. As you approach Tilton on the Hill take a left signposted to Cold Newton, Quenby hall and Hungarton. After 100m you will see the entrance to Stone Walls on your left hand side.
