A single building plot with outline planning permission for removal of the current cattery and erection of a three bedroom detached property, situated off Turweston Road, Brackley.

Site area approximately 0.07 acres (0.03 hectares).

Access to the plot is via a shared private drive, there is no mains gas or mains drainage to the plot.

Brackley is a market town in South Northamptonshire, the town has an attractive Market Place and town hall with 18th century buildings, a Medieval church and a range of shops, restaurants, takeaways, supermarkets and public houses. There is also an excellent choice of schooling in the area.

Proceed to the top of Pavillons Way and at the roundabut turn right and then left onto Bridgewater Road. Take the left turn onto Ellesmere Road and then the right turn onto Radstone Road. At the end of the road, turn left onto Northampton Road and at the roundabout, take the third exit onto Turweston Road. The plot can be found behind Somerset on the right hand side.
