On the first floor half landing is the family bathroom and a separate W.C. To the first floor is a beautiful sitting room that extends the entirety of the floor, on the second floor half landing is the third bedroom, whilst to the second floor there are two further bedrooms, the principal bedroom enjoying beautiful views across the Heath. On the third floor is a loft space that is currently utilised as an additional bedroom.
